Response of the OSBA to UGI Penn Natural Gas Inc. Interrogatories - Set I

#### Penn Natural Gas(OSBA)-I-5:

Refer to OSBA Statement No. 1, page 4. Please identify situations in which an investor owned utility would not be able to file a base rate proceeding, but would be able to petition for an increase in the DSIC cap.

#### Response:

As the interrogatory refers to Mr. Knecht's testimony at page 4, which provides Mr. Knecht's non-legal interpretation of legal language for granting a waiver of the DSIC cap. Please see also Mr. Knecht's testimony at pages 5-7 which explains why there may be uncertainty regarding that interpretation.

It is Mr. Knecht's (non-legal) understanding that an investor-owned utility is always able to petition for a waiver of and/or an increase in the DSIC cap.

Assuming the interrogatory was meant to refer to the circumstances under which a waiver of the DSIC cap could be granted even when a rate case option was available to the utility, Mr. Knecht observes that, under extraordinary circumstances, a utility may not have access to capital markets necessary to raise funds needed to safely operate its distribution system, without being able to obtain near term rate relief that could not be achieved promptly through a lengthy base rates proceeding.
