

Pursuant to 52 Pa. Code § 5.408(c), the Office of Small Business Advocate (“OSBA”) submits this response to your October 26, 2016, *Notification to the Parties of Official Notice Taken* (“Notification”).

In the *Notification*, you refer to a specific section of Appendix B in the *Petition of UGI Central Penn Gas, Inc. for Approval of their Modified Long-Term Infrastructure Improvement Plan (LTIIP)*, at Docket No. P-2013-2398835 (“*Petition*”), which provides a redline comparison of investments under the Company’s original and revised LTIIPs, for both historical and forecast years. The OSBA is uncertain as to how the referenced information is relevant to the issues in this proceeding, and observes that no party introduced this evidence as relevant. Nevertheless, the OSBA does not object to including information from the *Petition* in the record for this proceeding. However, in order to ensure that this information is presented in its proper context, the OSBA respectfully requests that Your Honor notice the entire *Petition*, including appendices.

Furthermore, the Pennsylvania Public Utility Commission (“Commission”) entered an Order on June 30, 2016, approving the *Petition*. The OSBA respectfully requests that Your Honor also notice the June 30th Order.


