Dear Ms. Davis:

UGI Central Penn Gas, Inc. ("UGI-CPG") herein respectfully requests an extension of the filing deadlines for the exceptions and reply exceptions established in the above captioned proceeding. UGI-CPG proposes that the due date for exceptions be established as January 4, 2017, and that the due date for reply exceptions be January 11, 2017. All parties to the UGI-CPG proceeding have been notified of the proposed alternative dates, and support the proposed schedule. Counsel for the Company has also spoken with the Office of Special Assistants, and was informed that this proposal to modify the due date of exceptions and reply exceptions will be granted.

The Recommended Decision for UGI-CPG was issued on December 5, 2016. The above captioned UGI-CPG proceeding has, in all phases prior to the issuance of the Recommended Decision, been conducted jointly with a similar DSIC waiver proceeding for UGI Penn Natural Gas, Inc. ("UGI-PNG"), at Docket No. P-2016-2537594. The Recommended Decision for UGI-PNG was issued on December 1, 2016.

Broadly speaking, the issues on exception in the two proceedings will be identical. Having separate due dates for the two proceedings is burdensome to the parties. Further, the parties agree that the holiday season may impact the ability to prepare and file exceptions and reply exceptions on the deadlines currently established in both proceedings. By moving the due dates, the parties can avoid making filings during the holiday period, align the due dates of the two

proceedings, and produce a single coherent theory applicable to both cases. The minor delay should not impact the overall consideration of these proceedings by the Commission. Therefore, UGI-CPG has requested that exceptions in its proceeding be due on January 4, 2017, and that reply exceptions be due on January 11, 2017.


