Dear Judge Buckley and Judge Myers:

To date, Pennsylvania-American Water Company ("PAWC" or the "Company") has been served with a number of formal complaints in the above-captioned matter and anticipates that additional formal complaints will be filed. On May 18, 2017, the Commission entered an Order initiating an investigation of the Company's rate increase request at the above-referenced docket number. The Company anticipates that all complaints filed with respect to its proposed rate increase will be consolidated in that proceeding. Accordingly, for any complaints served after May 18, 2017, the Company will rely upon 52 Pa. Code § 5.61(d), which provides:

For complaints which are docketed with Commission-instituted rate proceedings, an answer may be filed within 10 days of date of service. However, an answer is not required, except as may be directed by the Commission or the presiding officer.




