Secretary Chiavetta:

Please accept this notification of Joint Complainants of compliance with paragraph 67(c) of the Joint Petition for Approval of Settlement (Settlement), page 43 of the Initial Decision dated May 17, 2016, and the final Order dated August 11, 2016 in the above-captioned proceeding. On June 21, 2017, the Commonwealth of Pennsylvania, Office of Attorney General, through the Bureau of Consumer Protection (BCP) and the Acting Consumer Advocate, Tanya J. McCloskey (OCA) provided the May Report of the Administrator of the Refund Pool to Respond Power, LLC (Respond Power), the Pennsylvania Public Utility Commission's Bureau of Consumer Services, and Administrative Law Judges Elizabeth Barnes and Joel Cheskis in the format and medium requested by each.

Specifically, 53,879 checks were issued on November 23, 2016, representing checks to all eligible customers. Of those checks issued, 35,922 totaling \$2,448,144.63 were cashed and paid and 17,957 totaling \$1,101,597.71 were uncashed. Joint Complainants note that pursuant to the Settlement, the BCP and the OCA determined the amount of refund to offer to any individual

residential or small business customer based on the individual customer's usage, price charged and refund amounts already received. There is no correlation between the number of refund checks that were issued and the number of customers that were served by Respond Power during January, February, and March 2014.
