

**5. Relief**

Acting Consumer Advocate seeks the following relief:


- A. **Suspension and investigation pursuant to operation of Section 1308 (d) of the Public Utility Code.** The Company believes that further investigation of the merits of the proposed increase and delay will adversely impact the Company's financial viability. Subsequent to filing for a proposed rate increase with the Commission, the Company has responded to the Bureau of Technical Utility Services Water/Wastewater Division's May 21, 2017 Data Request 1 written and additional verbal data requests by Technical Utility Services and OCA.
- B. **Consolidate all complaints.** No customers have filed complaints about the rate increase or the service rendered. The only complaint is from the OCA.
- C. **Hold evidentiary hearings examining the reasonableness of the Company's existing and proposed rate increase.** The Company believes that the rate case can be resolved by discussions with OCA to clarify any issues and thus avoid the expense and financial burden on the Company of formal hearings.
- D. **Provide the public with adequate notice to allow customers the opportunity to be heard on the record.** No customers have filed formal or informal complaints about the proposed rate increase.
- E. **Deny any charges that cannot be fully justified.** The Company seeks only rates that can be justified based on public utility practice and policy.

- F. **Grant such other relief that the Commission may deem necessary.** The Company believes that it is in compliance with Public Utility Commission regulations and that other relief is not necessary.



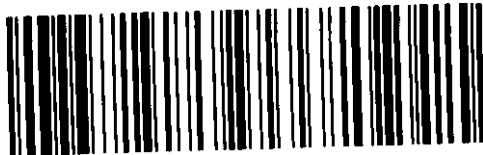
