As the state representative to Lower Makefield and Yardley, I write to express my concern regarding the proposed rate increase for the Pennsylvania American Water Company, Docket No. R-2017-2595853.

Lower Makefield and Yardley are serviced by PAWC. The proposed increase would add approximately \$150 a year to each households' yearly water bills, which would create an additional burden.

Recently PAWC customers in my district have experienced issues with brown water. While PAWC has taken corrective measures, I feel it would be imprudent to allow the utility to raise its rates until the situation has been fully resolved and safeguards have been implemented to prevent this from happening again.

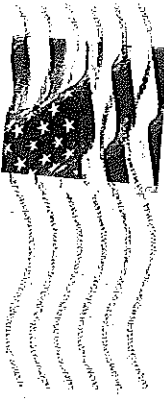
