3. TYPE OF UTILITY

4. COMPLAINT

- A. On August 7, 2017, Pine Roe Natural Gas Company (Pine Roe or Company) filed Supplement No. 40 to Tariff Gas Pa. P.U.C. No. 1, requesting an increase in base rates for all customer classes served by Pine Roe.
- B. Pine Roe is a natural gas distribution company serving 165 residential customers in portions of Beaver, Clarion, Monroe, and Piney Townships in Clarion County,
 PA.
- C. The Company is requesting an overall rate increase of \$50,000.00 per year, all of which would come from an increase to the Customer Charge. A typical residential customer using 8.5 MCF of natural gas per month would see a total bill increase from \$29.01 to \$54.26 per month, or 87%.
- D. The current customer charge of \$6.61 includes the first 2 Mcf of natural gas.

Under the Company's proposal, the customer charge would continue to include the first 2 Mcf of natural gas but the charge would increase to \$31.86, or by 381.997%.

- E. The Consumer Advocate is empowered to represent the interest of Pennsylvania consumers before the Pennsylvania Public Utility Commission, pursuant to Act 161 of the General Assembly, as amended. 71 Pa. Stat. Ann §§ 309-1 et seq.
- F. A preliminary examination of the Company's filing indicates that the proposed increase to annual revenues of \$50,000.00 may be unjust, unreasonable, in violation of law and will or may produce an excessive return on investment in violation of the Public Utility Code. 66 Pa.C.S. § 1301, et seq.
- G. The Acting Consumer Advocate also avers that the proposed tariff changes and proposed rate design may be unlawfully discriminatory, in violation of the Public Utility Code, 66 Pa.C.S. Sections 1301 and 1304, et seq., and may otherwise be contrary to sound ratemaking principles and public policy.
- H. The Acting Consumer Advocate files this complaint to ensure that the Commission fully and fairly adjudicates issues pertaining to whether the Company's proposed rates and all rate policy changes are just, reasonable, and otherwise lawful.

5. RELIEF

The Acting Consumer Advocate respectfully requests that the Commission take the following actions:

A. Suspend and investigate the operation of the proposed Supplement No. 4, pursuant to Section 1308(d) of the Public Utility Code, 66 Pa.C.S. § 1308(d);

- B. Consolidate all complaints filed against the proposed increase;
- C. Hold full evidentiary hearings examining the reasonableness of the proposed increases in rates;
- D. After providing the public with adequate notice, hold public input hearings in the Company's service territory, in order to provide its customers with an opportunity to be heard on the record;
- E. Deny any changes contained in the proposal which cannot be fully justified, or which otherwise are contrary to the Public Utility Code, sound ratemaking principles, and public policy;
- F. Grant such other relief, which the Commission may deem to be necessary and proper.

PUBLIC STATEMENT OF THE OFFICE OF CONSUMER ADVOCATE PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. Section 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (Commission). In accordance with Act 161, and for the following reasons, the Acting Consumer Advocate determined to file a Formal Complaint and participate in proceedings before the Commission involving the proposed rate increase requested by Pine Roe Natural Gas Company (Pine Roe or Company).

Under the Company's proposal, Pine Roe would receive additional annual revenues of \$50,000.00. A customer using 8.5 MCF of gas per month would see a total bill increase from \$29.01 to \$54.26 per month, or by 87%. The Company serves 165 residential customers, in portions of Beaver, Clarion, Monroe, and Piney Townships in Clarion County, PA.

The objective of the Acting Consumer Advocate in filing a Formal Complaint in this matter is to protect the interests of the Company's customers. The Acting Consumer Advocate will seek to ensure that the Company is permitted to implement only a level of rates that is fully justified and in accordance with sound ratemaking principles. The Acting Consumer Advocate will strive to prevent the Company from collecting from ratepayers all alleged costs that cannot be justified, or are unreasonable or unduly discriminatory, or otherwise violate the Public Utility Code.
