As set forth in Ordering Paragraph No. 8 of the Order entered October 5, 2017 ("Order"), Metropolitan Edison Company ("Met-Ed") hereby provides notice that North Heidelberg Sewer Company ("NHSC") failed to comply with requirement outlined in Ordering Paragraph No. 6 of the Order, which had a deadline of December 4, 2017.¹ Specifically, Met-Ed offers the following status of accounts as of December 11, 2017 for NHSC:

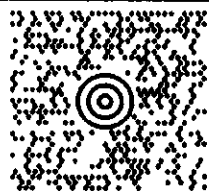

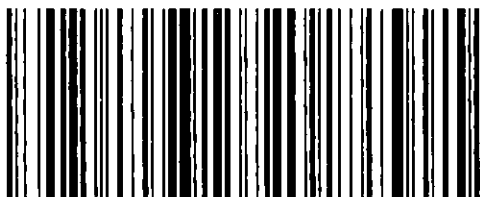
