By Order entered December 21, 2017, at R-2017-2631441, the Public Utility Commission suspended Reynolds Water Company's Supplement No. 5 to Tariff Water-Pa. P.U.C. No. 4, until August 1, 2018 and opened an investigation into it. This tariff supplement extends the August 1, 2018 effective date of Supplement No. 5 to October 1, 2018, to permit Reynolds Water Company to try to resolve the investigation through the Mediation Process. Presently effective rates contained in Tariff Water – Pa. P.U.C. No. 4 and supplements thereto will continue in effect until otherwise amended.
