I file this protest for several reasons. First of all, I am highly opposed to the installation of the High Voltage Power Lines in our area due to the unknown long-term health effects from the radiation emitted which could be detrimental to my family's and friends' health. Second, I am also concerned about the effects on the surrounding farm's livestock and wildlife in the area.

My husband and I are property owners and are very concerned how the installation of these lines and the unsightly 135 foot towers will most definitely lower the value of our house and property. We are also concerned the project would place a heavy burden on county services and our roadways resulting in an increase in our taxes.

To my knowledge residents of Franklin County will not benefit in any way from this project as the project will only benefit those consumers in Baltimore, Washington, DC; and Northern Virginia areas. The excavation needed for this project will most certainly destroy good farm land in our area effecting the county's and surrounding area farmers and families' livelihood without any benefit for them.

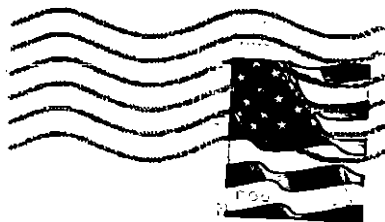
