I have been asked to forward this letter to your office as well.

This letter is in reference to the representative from Transource – Western Land Services-Joleen DiMaggio coming onto my property numerous times after I have told her I was not giving the okay for them to do and surveying or research concerning the proposed Rice Road West Project.

Nov. 3, 2017—first visit from Joleen DiMaggio

She introduced herself and whom she was representing and why she was here, which was to gain permission to enter my property for them to do their studies, as I am a landowner who would be directly affected by the project. I immediately told her I was not giving permission at any time.

Jan. 9, 2018—2nd visit from Joleen and I was not home at the time so she left her card and note stating, “Sorry I missed you, Transource Electrical Easement, Please give me a call.” Thank you, Joleen and again her card.

Jan. 26, 2018—3rd visit from Joleen and same info as above in # 2

I meet her at the end of my driveway and she again said who she was, as if I did not know, and I said “Yes I know who you are.” Once again I told her I was not giving permission for Transource to come on my property to do their survey and research. She says, “So you want me to tell them at the office that you are saying, “No”. I said, “Yes that’s correct!”

Feb. 9, 2018—4th time she is here again leaving her card and the sorry I missed you along with the same letter that I had received in the mail on Feb. 7th from Western Land Services. This letter is saying that it is the final attempt to gain voluntary access to your property for survey work and statutory 10-day notice.

Twice in between the Jan 9th and Jan. 26th, I received phone calls from her. The first I was not home and she left a message to call her back, which I intentionally did not do. The second time she called not recognizing the number, I answered the phone. When she said who she was I did in fact hang up on her.

I feel that this lady and Western Land Services are now harassing me and I am tired of it. I have stated my position to them and they need to respect that. On December 30, 2017 I had already signed the “ deny of right of way access” and it was sent to them.

I then told them I did not give permission to be on my property, nor were they given permission to be on the right of way to the substation as it was also on my property. They stated they were trying to find the boundary marker which I informed them where it was and to please get off my property. They did get off my property and went onto the neighbors to attempt to find the boundary marker.
