

4. On March 29, 2018, PECO filed a request for a base rate increase of approximately \$82 million.

5. IBEW anticipates numerous issues being raised in this proceeding that will or may affect its interests as a representative of PECO's employees and retirees and as a customer of PECO. For example, PECO's filing includes claims regarding employment levels, employee wages and benefits expenses, and pension funding, among others. In addition, issues may be raised by various parties concerning the safety or reliability of PECO's service that will or may have a direct effect on IBEW and its members.

6. No other party to this proceeding represents the interests of IBEW and its members.

7. IBEW intends to actively participate in this proceeding on such matters that affect its interests as a customer of PECO and the interests of its members as employees and retirees of PECO. Such participation may include the presentation of direct or rebuttal testimony and the cross-examination of witnesses presented by PECO and other parties to this proceeding.

WHEREFORE, International Brotherhood of Electrical Workers, Local 614 respectfully requests the right to intervene as an active party in this proceeding.


