Dear Secretary Chiavetta:

PECO Energy Company (the “Company”) has received formal complaints filed by the Office of Consumer Advocate and the Office of Small Business Advocate in the above-captioned matter.<sup>1</sup> The Company anticipates that additional complaints may be filed against the proposed rate increase. On April 19, 2018 the Pennsylvania Public Utility Commission (the “Commission”) entered an Order initiating an investigation of the Company’s rate increase request. Consistent with Commission practice, all complaints will be consolidated in that proceeding. Accordingly, with respect to the complaints that have been filed, and any complaints hereafter filed, the Company, in lieu of filing answers thereto, will rely upon 52 Pa. Code § 5.61(d), which provides:

For complaints which are docketed with Commission-instituted rate proceedings, an answer may be filed within 10 days of date of service. However, an answer is not required, except as may be directed by the Commission or the presiding officer.

If the Commission directs that answers should be filed to any complaints, we request that the Company be provided 10 days from the date of such directive to file answers to such complaints.


