Enclosed herewith, please find Columbia Gas of Pennsylvania Inc.'s ("Columbia") annual reports pursuant to the reporting requirements covered in 66 Pa.C.S. Sections 1410.1(3) and 1410.1(4) and the Commission's Chapter 14 Implementation Final Order in Docket No. M-2014-2448824.

These reports represent a "snapshot" of residential statistical data as of December 31, 2017, and cover the following metrics:

- 1) The number of residential active accounts with an arrearage of \$10,000.00 or more. (Exhibit A).
- 2) The number of medical certificates/renewals submitted and the number of medical certificates accepted by the utility. (Exhibit B).
