## II. Full EDI Capability Implementation Timing

As Pike discussed in its last monthly update, once Pike signs a contract with a software vendor, it is estimated that full-EDI capability can be implemented within 8 months. Pike has not yet executed a contract because it is unsure whether the Commission has required it to implement full EDI capabilities prior to conducting a cost-benefit analysis and is awaiting the Commission's clarification or reconsideration on that matter pursuant to Pike's March 30, 2018 Petition for Clarification or Reconsideration in this proceeding.

#### III. Current Supplier Changes

Pike currently implements switching and other EDI functions via a manual process. Pike is in contact contacts with the EGS's on its system via e-mail to communicate switching. On average Pike processes about 20 transactions per month switching customers between EGSs, to an EGS, or from and EGS back to Pike. Pike also receives e-mail notifications when an EGS customer's rates change. This change is manually input into Pike's CIS system. Pike generates monthly reports from its CIS that show the number of transactions and dollar amounts associated with each Pike account's transaction with each of the EGSs.
