Please be advised that the Office of Consumer Advocate will not be filing Exceptions to the Recommended Decision in the above-referenced proceeding. On May 29, 2018, the Secretary served the Recommended Decision of Administrative Law Judge Dunderdale (ALJ). In the Recommended Decision, the ALJ recommended approval of the Joint Petition for Settlement (Settlement or Petition) filed by Reynolds Water Company (Reynold or Company), the Bureau of Investigation and Enforcement (I&E) and the Office of Consumer Advocate (OCA) with some minor modifications.
