PIKE COUNTY LIGHT & POWER COMPANY'S FIFTH MONTHLY STATUS REPORT ON IMPLEMENTATION OF ELECTRONIC DATA INTERCHANGE

Pursuant to the Commission's March 15, 2018 Order<sup>1</sup> in this proceeding, Pike County Light & Power Company (Pike) submits this status report regarding implementation of Electronic Data Interchange (EDI) capability.

In Pike's previous reports, it has documented the steps taken to analyze what Pike would need to do to implement EDI. After several months of review of the file formats required under Pennsylvania's EDI Rules and the interfaces that would need to be constructed to allow Pike's current customer information system to work with EGS systems, Pike has concluded that the cost likely outweighs the benefits.

Pike's Customer Information Service (CIS) vendor estimates that multiple EDI integrators, a minimum of approximately 30 different interfaces, would need to be created by our CIS vendor. Exclusive of integrator cost, the minimum cost to implement a solution to allow for the EDI integration is estimated to be between \$240,000 USD with the potential of being as high as \$450,000 USD. This does not include any development work that may be needed at the moment.

Pike currently has 2,215 EGS customers, approximately 47% of the total customer base. From September 27, 2017 when Pike's CIS went live through July 31, 2018, the company received 123 customer add/drop or rate change files from EGSs on its system. This works out to 1 transaction every 2.5 days. Currently, two CIS personnel at Pike and one energy supply specialist at Corning Natural Gas Company (Pike's affiliate) process these files. The data below shows the number of such transactions per month for the last quarter.

The company has been informed by its CIS vendor that it would need to spend between \$240,000 to \$450,000 to modify its existing CIS software to work with EDI. Beyond the initial CIS vendor programing cost identified the company would incur annual fees from EGS integrator of \$35,000 to \$40,000. The company believes it would be more cost effective to hire

another customer service employee with the primary job responsibility of updating CIS

information with EGS customer changes. Additionally, the company and its CIS vendor believe

they can develop a more cost effective hybrid approach that minimizes data entry errors while

remaining economical. Given the limited number of EGS transactions to date this seems to be a

more prudent course of action. Pike will file a more detailed cost-benefit analysis in September.
