To Our Customers:

B. E. Rhodes Sewer Company (the "Company") is filing a request with the Public Utility Commission ("PUC") to increase your sewer rates as of November 15, 2018. This notice describes the company's rate request, the PUC's role, and what actions you can take.

The Company has requested an overall rate increase of \$14,228.44 per year. If the company's entire request is approved, the total bill for a residential customer using 500 cubic feet would increase from \$31.34 to \$37.00 per month or by 18.06%. The total bill for a commercial customer using 4,800 cubic feet would increase from \$207.21 to \$244.69 per month or by 18.09%. The total bill for an industrial customer using 2,000 cubic feet would increase from \$92.69 to \$109.45 per month or by 18.08%. The total bill for a public customer using 200 cubic feet would increase from \$19.07 to \$22.51 per month or by 18.04%.
