UGI Utilities, Inc. – Electric Division ("the Company") is filing this letter in response to the "Exceptions To The October 26, 2018 Compliance Filing of UGI Utilities, Inc. – Electric Division On Behalf Of The Office of Small Business Advocate" filed by the Office of Small Business Advocate ("OSBA") on November 8, 2018. As shown herein, the OSBA's exceptions have been filed untimely, and therefore they should be rejected.

The date of service for the Commission's purposes is governed by 52 Pa. Code § 1.56, which provides in relevant part:

(a) The date of service will be the earliest day when the document served meets one of the following conditions:

The OSBA correctly identifies in its exceptions that the Company's electronic service of the compliance filing occurred on October 26 at 5:07 p.m. However, the Company also served the filing on October 26 via express overnight delivery. Enclosed is a copy of the electronic receipt received from Federal Express for the service of the compliance filing to the OSBA on Friday, October 26, 2018.
