Dear Secretary Chiavetta:

The Office of Small Business Advocate (“OSBA”) filed Exceptions to the Compliance Filing of UGI Utilities, Inc. – Electric Division (“UGI Electric” or the “Company”) on November 8, 2018. A dispute arose between UGI Electric and the OSBA as to the timeliness of the OSBA Exceptions. The disagreement involves on what date UGI Electric perfected service of the Company’s Compliance Filing -- Friday, October 26, 2018, or the following Monday, October 29th.

Previously, UGI Electric and the OSBA conducted settlement discussions to address the issues ultimately raised in the OSBA’s Exceptions. Those discussions expanded to include the issue of service of the Compliance Filing itself.

Due to the Commission action in this case, the Company has already placed its rates into effect. The OSBA is aware of that fact, and that it would be difficult for the Company to revise its rates at this time.

Therefore, UGI Electric and the OSBA have agreed to jointly file this letter in settlement of all issues involving the Company’s Compliance Filing. Specifically, the OSBA agrees to withdraw its November 8th Exceptions to the Company’s Compliance Filing. UGI Electric agrees to withdraw its November 9th letter requesting the rejection of the OSBA’s Exceptions.




Furthermore, the OSBA and UGI Electric agree that the Company will not cite to the Compliance Filing as precedent in any future case before the Pennsylvania Public Utility Commission. The OSBA agrees that it will not otherwise challenge the Company's Compliance Filing in light of the unique circumstances present in this proceeding.

Finally, the parties agree to work together on a best efforts basis to address in a future base rate proceeding the issues identified by the OSBA in its Exceptions.


