### PUBLIC STATEMENT OF THE OFFICE OF SMALL BUSINESS ADVOCATE

The Small Business Advocate is authorized and directed to represent the interest of small business consumers of utility services in Pennsylvania under the provisions of the Small Business Advocate Act, Act 181 of 1988, 73 P.S. §§ 399.41 - 399.50 (the "Act"). The Act further provides that the Small Business Advocate is to issue publicly a written statement stating concisely the specific interest of small business consumers to be protected by his initiation of or intervention in any proceeding involving those interests before the Public Utility Commission (the "Commission") or any other agency or court. This public statement relates to the filing today by the Small Business Advocate of a Notice of Intervention in the proceeding commenced by Sprint Communications Company L.P. ("Sprint" or "the Company") of its Application for Approval of a General Rule Indirect Transfer of Control ("Application"). The Application requests Commission approval of a merger transaction that will result in an indirect change in control from Sprint Corporation to T-Mobile USA, Inc., resulting in Sprint becoming a wholly owned subsidiary of T-Mobile USA, Inc.

The Small Business Advocate files this Notice of Intervention in order to protect the interests of the Company's small business customers. A thorough inquiry by the Commission into all of the elements of the Application is necessary to ensure that the proposed transaction is

in the public interest and affirmatively promotes the service, accommodation, convenience, or

safety to the public in some substantial way.

In view of the foregoing, the Small Business Advocate will participate in proceedings

before the Commission to investigate the transaction proposed in the Application. The Small

Business Advocate will ask the Commission to deny the proposed transaction if it is not in the

public interest and does not affirmatively promote the service, accommodation, convenience, or

safety of the public in some substantial way.
