UGI Utilities, Inc. – Gas Division ("UGI Gas") filed a Petition for Rescission with the Pennsylvania Public Utility Commission ("Commission") on January 13, 2017. The Petition requested a minor modification to the Opinion and Order issued in the above captioned proceeding on November 9, 2016. In its Petition, UGI Gas requested that Ordering Paragraph No. 6 be revised to eliminate the annual need to file job creation data. As of the time of filing of this letter, no order has been issued.


On January 10, 2018, the Company filed a letter with the Secretary's Bureau requesting clarification on how to proceed with the January 31, 2018 compliance filing. The Secretary's Bureau issued a Secretarial letter on January 23, 2018, waiving the stand-alone compliance filing requirement for 2018.

As there is still no order entered on the Petition, UGI Gas files this letter to seek the same treatment for 2019 that it was granted in the January 23, 2018 Secretarial Letter. The Company requests that the Secretary's Bureau determine that the Company is not required to make a compliance filing on January 31, 2019.


