1 Q. PLEASE STATE YOUR NAME AND BUSINESS ADDRESS.

2 A. My name is Eric Petrichevich and my business address is 375 North Shore Drive,

3 Pittsburgh, Pennsylvania 15212.

4

5 Q. BY WHOM ARE YOU EMPLOYED AND IN WHAT CAPACITY?

6 A. I am employed by PNG Companies LLC who provide services to Peoples Natural Gas
7 Company LLC (“Peoples” or “Company”). I am in the Finance and Treasury Department.
8 My job title is Senior Financial Analyst.

9

10 Q. PLEASE DESCRIBE YOUR EDUCATIONAL BACKGROUND AND WORK
11 EXPERIENCE

12 A. I graduated from the University of Pittsburgh with a bachelor's degree in Finance and
13 Accounting. I started as an intern for Peoples in 2012 and was brought on full-time as a
14 financial analyst in 2013 and have worked here since.

15 Q. HAVE YOU TESTIFIED PREVIOUSLY IN ANY REGULATORY
16 PROCEEDING?

17 A I have not

18 Q. ARE YOU SPONSORING ANY FILING REQUIREMENTS OR OTHER
19 EXHIBITS?

20 A. Yes, I am. Attached to this Direct Testimony as Appendix A is a complete list of the
21 exhibits for which I am the responsible witness.

1 **Q. WHAT IS THE PURPOSE OF YOUR TESTIMONY IN THIS PROCEEDING?**

2 A. I am responsible for developing the value of Cash Working Capital. I have also prepared
3 **Peoples Exhibit No. EJP-1**, which includes the lead-lag study in support of the
4 Company's cash working capital requirement pursuant to Section 53.53 III. A.15 of the
5 Commission's standard filing requirements.

6 **Q. HAS THE COMPANY PERFORMED A STUDY TO DETERMINE THE LEVEL
7 OF CASH WORKING CAPITAL THE COMPANY REQUIRES TO FINANCE
8 ITS DAY-TO-DAY OPERATIONS?**

9 A. Yes, the Company performed a lead-lag study by analyzing the Company's cash
10 transactions and invoices for the twelve months ended September 30, 2018.

11 **Q. PLEASE DEFINE WHAT YOU MEAN BY THE PHRASE "CASH WORKING
12 CAPITAL".**

13 A. Cash working capital is the amount of funds required to finance the day-to-day operations
14 of the Company.

15 **Q. HOW SHOULD THE RESULTS OF THE CASH WORKING CAPITAL
16 ANALYSIS BE TREATED FOR RATEMAKING PURPOSES?**

17 A. The cash working capital requirements should be included as part of the Company's rate
18 base for ratemaking purposes.

19 **Q. DID YOU PREPARE A SEPARATE STUDY FOR THE PEOPLES DIVISION AND
20 THE EQUITABLE DIVISION?**

1 **A.** No. The study to develop the lead/lag day was performed on a combined basis as the
2 Company finances its day-to-day operations on a combined basis. Therefore, it would be
3 inappropriate to segment the study. However, the results were applied to the divisional
4 operations to show the cash working capital claim by division.

5 **Q. WHAT IS A LEAD-LAG STUDY?**

6 **A.** A lead-lag study is an analysis of the differences between the revenue “lags” and the
7 expense “leads” of a utility. The revenue lag reflects the time between the date customers
8 receive service and the date that customers’ payments are available to the utility. This
9 revenue lag is offset by an expense lead time during which the utility receives goods and
10 services, but pays for them at a later date. The leads and lags are both measured in days.
11 The dollar-weighted lead and lag days are then divided by 365 to determine a daily cash
12 working capital factor (“CWC factor”) for each specified expense category in the study.
13 These CWC factors are then multiplied by the applicable annual test year cash expenses to
14 determine the amount of cash working capital required for operations. The resulting
15 amount of cash working capital is then included as part of the utility’s rate base.

16 **Q. WHAT ARE THE VARIOUS LEADS AND LAGS THAT SHOULD BE
17 CONSIDERED IN A CASH WORKING CAPITAL ANALYSIS?**

18 **A.** Two broad categories of leads and lags should be considered: 1) lag times associated with
19 the collection of revenues owed to the utility; and 2) lead times associated with the
20 payments for goods and services received by the utility.

1 **Q. WHAT WAS THE SOURCE OF INFORMATION YOU EMPLOYED TO**
2 **DETERMINE THE LEADS AND LAGS IN YOUR CASH WORKING CAPITAL**
3 **ANALYSIS?**

4 A. Data from the Company's Accounts Payable, Accounts Receivable, Payroll, and Tax
5 accounts were utilized. The information derived from these sources, together with
6 analyses of specific invoices, led to the determination of the appropriate number of lead-
7 lag days for the Company.

8 **Q. WHAT IS A REVENUE LAG AND HOW IS IT DETERMINED?**

9 A. The revenue lag measures the number of days from the date service was rendered by the
10 Company until the date payment was received from customers and such funds were
11 available to the Company. In this study, the revenue lag was divided into three distinct
12 components: 1) service lag; 2) billing lag; and 3) collections lag. Considered together,
13 these three components of retail revenue lag totaled a weighted average of 63.90 lag days.
14 An explanation of each component of the base revenue lag follows.

15 **Q. WHAT IS MEANT BY SERVICE LAG?**

16 A. The service lag refers to the period of time from when service is rendered to the time the
17 customer's meter is read. Using the mid-point methodology, the average service lag
18 associated with meter reading was 15.21 days (365 days in the year divided by 12 months
19 divided by 2). Twelve months was appropriate to use for purposes of determining the
20 service lag because the Company bills its customers monthly.

21

22 **Q. WHAT IS THE MID-POINT METHODOLOGY?**

1 A. For purposes of determining the service lead or lag, the Company's methodology
2 presumes that the service was provided (or received) evenly over a given period (i.e., a
3 month). Adding the one-half month to the derivation of the lead or lag is referred to as the
4 mid-point methodology.

5 **Q. WHAT IS MEANT BY BILLING LAG?**

6 A. Billing lag refers to the average number of days from the date on which the meter was read
7 until the date a customer is billed. Based upon the percentage weighted distribution of the
8 mailing of the bills, in accordance with the most recent management audit, the Company
9 determined the billing lag to be 1.0 day.

10 **Q. WHAT IS MEANT BY COLLECTIONS LAG?**

11 A. The collections lag refers to the average amount of time from the date when the Company
12 mailed a bill to the date that the Company received payment from its customers. As
13 shown on page 4 of Exhibit EJP-1, the Company calculated collections lag using the days
14 in accounts receivable methodology. First, average monthly accounts receivable is
15 calculated by adding the end of month accounts receivable balances for each month in the
16 preceding 13 months to the historic test year and dividing the total by 13. Then, A/R
17 Turnover is calculated by taking the trailing twelve months sales divided by the average
18 accounts receivable balance. Finally, we calculate the collection days lag by taking 365
19 divided by the A/R Turnover previously calculated. Based on this approach, the average
20 collection lag at the Company was determined to be 47.69 days.

21 **Q. PLEASE SUMMARIZE THE CALCULATION OF REVENUE LAG DAYS.**

- 1 A. The calculation of the overall revenue lag, by lag component is summarized in the
2 following table:

Revenue Lag Component	Lag Days
Service Lag	15.21
Billing Lag	1.0
Collections Lag	47.69
Total Lag Days	63.90

3 **Q. WHAT EXPENSE-RELATED LEADS WERE CONSIDERED IN THE LEAD LAG
4 ANALYSIS?**

- 5 A. Lead times associated with the following expense categories were considered in the study:
6 a) Gas Purchase Costs; b) Payroll; c) Pensions and Benefits, d) Taxes other than Income
7 Taxes, e) Other Operations and Maintenance Expenses; f) Federal Income taxes; g) State
8 Income Taxes; h) Interest on Long-term Debt; and i) Interest on Short-term Debt.

9 **Q. WHAT TYPES OF LEADS WERE ASSOCIATED WITH THE COMPANY'S
10 PURCHASES OF NATURAL GAS?**

- 11 A. Pipeline companies typically send out invoices around the 10th of the month following the
12 service month with payments due 10 days later. Payments to suppliers were made
13 electronically. The Company also purchases gas from local producers. The Company
14 reads the meters at the end of each month and cuts a check to the producer on the last day
15 of the following month. As shown on pages 5 through 10 of Exhibit EJP-1; the company
16 used payment data for the twelve months ended September 30, 2018, and determined that

1 the expense lead time associated with payments for natural gas and pipeline services,
2 including 15.21 days of service lead time, was 37.92 days.

3 **Q. PROVIDE AN EXPLANATION OF THE LEAD ASSOCIATED WITH THE**
4 **COMPANY'S PAYROLL EXPENSES.**

5 A. The Company's payroll records were analyzed to measure the number of lead days
6 between the Company's receipt of services from its employees and the payment for those
7 services. As shown on page 11 through 13 of Exhibit EJP-1, payroll lead days were
8 calculated by: a) calculating the unweighted (or nominal) lead time by pay day and pay-
9 cycle including a mid-point of the pay period as indicative of a service lead time and
10 weighting the resulting lead days by the amounts paid out by the Company to cover its
11 payroll obligations. The company's pay-roll cycles are bi-weekly; resulting in a total
12 average payroll expense lag of 15.23 days.

13 **Q. WHAT TYPE OF LEADS ASSOCIATED WITH THE COMPANY'S EMPLOYEE**
14 **BENEFIT PROGRAMS WERE CONSIDERED IN THE ANALYSIS?**

15 A. As shown on pages 14 and 15 of Exhibit EJP-1, the estimated lead times associated
16 with the following major categories of the Company's employee benefit programs were
17 considered: a) pensions; and b) employee benefits including group life, group health, and
18 other employee programs. Peoples is switching from being self-insured in 2018 to
19 purchasing medical insurance in 2019. Therefore, the medical benefits calculation is for
20 lead time of premium payments is based off of an estimated monthly premium amount.
21 These premiums will be paid in full before the next month of coverage begins. All of

1 these benefits and programs taken together, had a dollar-weighted lead time of 50.78
2 days.

3 **Q. DID THE COMPANY MAKE CONTRIBUTIONS TO THE DEFINED BENEFIT**
4 **PENSION FUND (“DB”) DURING THE HISTORIC TEST YEAR?**

5 A. Yes. The Company made quarterly contributions to the pension fund for its unionized
6 employees. The contributions were typically made around the 15th day of the month
7 following the end of a quarter (for the Equitable division DB plan). For Pension (both
8 divisions) and Post Retirement (Peoples Division only) costs are accrued monthly based on
9 a study provided by AON Hewitt in early January each year. This helps to appropriately
10 align the costs to the appropriate service period for both the pension and post retirement
11 benefits. In December of each year, any necessary funding contributions are calculated
12 and then paid into the plans before December 31.

13 **Q. HOW WAS THE EXPENSE LEAD TIME ASSOCIATED WITH THE**
14 **COMPANY’S OTHER BENEFIT PROGRAMS DETERMINED?**

15 A. The Company is billed monthly by each of its benefit providers. The bill may consist of
16 service costs and/or administrative fees. The invoices are typically paid within one week
17 following the receipt of the invoice. Funds for 401K accounts are sent the day following
18 pay day.

19 **Q. WHAT ARE OTHER OPERATIONS AND MAINTENANCE EXPENSES AND**
20 **WHAT LEAD TIMES WERE ASSOCIATED WITH SUCH EXPENSES?**

21 A. The Company engages in transactions with other vendors (not associated with pensions,
22 benefits, payroll, natural gas and pipeline services, or taxes) for a variety of purposes

1 including facility maintenance, maintenance of system reliability, and customer service.
2 As shown on pages 16 through 19 of Exhibit EJP-1, a random sample of invoices from
3 providers of such services were analyzed in order to estimate a lead time associated with
4 payment for services related to other operations and maintenance activities. The analysis
5 indicates that on average, invoices were paid by the Company 40.12 days after receipt.

6 **Q. WHAT ARE THE GENERAL TAXES CONSIDERED IN THE ANALYSIS OF**
7 **EXPENSE LEADS?**

8 A. As shown on page 20 through 22 of Exhibit EJP-1, the following general taxes and similar
9 assessments were considered in the study: a) property taxes; b) State & Federal Alternative
10 Fuel Taxes; c) U.S. DOT Fees; d) Federal Heavy Highway Taxes; e) OCA/PUC/OSBA
11 assessments; f) WV Gas Stored Tax; g) PURTA; and h) Sales and use taxes. Payroll-
12 related taxes were not considered in the analysis because the funds associated with those
13 taxes are forwarded to our payroll processor, at the same time as the payroll funds. The
14 payroll processor is then responsible for remitting the funds to the appropriate taxing
15 bodies. When dollar-weighted using twelve months ended September 30, 2018 actual
16 payments, the weighted expense lead time for all categories of these general taxes was
17 determined to be 32.16 days. This weighted lead time was then used in computing the
18 cash working capital requirement associated with taxes other than income taxes.

19 **Q. HOW DID YOUR STUDY ADDRESS INCOME TAXES?**

20 A. As shown on page 23 of Exhibit EJP-1, for Federal and State income taxes, the statutory
21 payment schedules relative to each tax were utilized to arrive at 37.00 and 54.90 lag days,
22 respectively.

1 **Q. PROVIDE A DESCRIPTION OF HOW LEAD TIMES ASSOCIATED WITH THE**
2 **COMPANY'S INTEREST EXPENSE ON LONG-TERM AND SHORT -TERM**
3 **DEBT WERE ADDRESSED BY THE STUDY.**

4 A. As shown on page 24 of Exhibit EJP-1, interest expense on long term debt was assigned
5 expense lag days based on the semi-annual payments of the Company's installment
6 promissory notes to arrive at an average of 90.38 days. Short term debt was assigned
7 expense lag days based on the monthly interest payments, on the company's working
8 capital balance, of the Company's Intercompany Demand Note to arrive at an average of
9 19.95 days.

10

11 **Q. HAVE YOU PREPARED AN EXHIBIT THAT SUMMARIZES THE RESULTS OF**
12 **YOUR ANALYSIS OF THE COMPANY'S CASH WORKING CAPITAL**
13 **REQUIREMENTS?**

14 A. Yes. The results of the cash working capital study are presented in Peoples Exhibit No.
15 EJP-1, pages 1 to 3. As shown on page 3, the total cash working capital claim is
16 \$35,196,645. This amount is included in rate base in Peoples Exhibit No. 2. Peoples
17 Exhibit No EJP-1 is attached following my testimony.

18

19 **Q. DOES THIS COMPLETE YOUR PREPARED DIRECT TESTIMONY?**
20 A. Yes, it does. I reserve the right to submit additional testimony as issues arise during the
21 course of the proceeding. Thank you.
