This public statement relates to the filling today by the Small Business Advocate of a Notice of Intervention in the proceeding commenced by Pennsylvania-American Water Company ("PAWC" or the "Company") regarding its Application for approval of the transfer, by sale, of substantially all of Steelton Borough Authority's assets, properties and rights related to its water system to PAWC ("Application") filed on January 2, 2019.

The Small Business Advocate files this Notice of Intervention in order to protect the interests of the Company's small business customers. A thorough inquiry by the Commission

The Small Business Advocate will ask the Commission to deny or modify any aspect of the Application that is not proven by PAWC to be in accordance with the Public Utility Code, all other applicable statues, and Commission regulations and orders.
