

**NOTICE OF QUESTION AND ANSWER SESSION
TO BE HELD FEBRUARY 18, 2019**

TO OUR CUSTOMERS:

By now, you will have received a Notice advising that Buck Hill Water Company has filed a request with the Pennsylvania Public Utility Commission (PUC) to increase water rates.

The Company has not sought an increase in rates in almost 15 years. In the interim, the cost of operating the Company and of maintaining its filtration and distribution infrastructure has steadily increased. Since the last rate filing in 2004, the Company has added over \$900,000 in water system assets. This year, the Company expects to spend an additional \$360,000, mostly on required maintenance of the filtration facility.

The Company agreed, as part of the settlement of the 2004 proceeding to sponsor a Question and Answer session in the Buck Hill Falls community to inform customers about the rate filing before any public input hearing that might be scheduled. The Question and Answer session will be held as follows:
