No other water or wastewater violations in PAWC's neighboring operating areas were received. Pennsylvania American Water – Glen Alsace System NOV Plan of Action for Operator Training and Well Operations

The following information details the occurrence and subsequent remedial actions from a recent PA DEP routine inspection that noted groundwater wells being operated in excess of permitted maximum instantaneous pumping rates in the Glen Alsace System (PWS ID #3060088).

<u>Incident details:</u> During a routine on-site inspection at Pennsylvania American Water Glen Alsace Water System, Wells 8, 12A and 13 were being operated in excess of the permitted maximum instantaneous pumping rates. Pennsylvania American Water received an NOV for failing to operate the wells in a manner consistent with the PA DEP approved operating permit.

<u>Short-term remediation:</u> All Operators associated with well operations were provided comprehensive review and training on each well's operating permit, including maximum instantaneous flow limits and minimum chlorine residuals to maintain compliance with the Ground Water Rule and any operating permit and applicable regulation. Placards were also placed in each well, detailing permit conditions to reinforce these requirements. New Operator training will emphasize operating and permit conditions to maintain compliance.

Well 8 operation was addressed by re-spanning the flow cell to proper calibration settings to provide accurate flow data. This information was communicated previously to PA DEP. Well 8 remains in compliance with the associated operating permit. Well 12A and 13 operation was adjusted by restricting each well's gate valve so the flow will not exceed the maximum allowable amount. Since our meeting on September 10, the existing Cla-Val in Well 12A was rebuilt and is now utilized as intended to control flow. Evaluations for improvement on each well's operation and valve process are on-going.

<u>Long-term solution:</u> Pennsylvania American Water will continue to evaluate each well and determine a suitable plan of action based on existing well condition and continue to educate staff on any changes to well operations. Based on these evaluations, the following options will be performed:

- evaluate each well to determine whether Cla-Val or VFD motors will be utilized to control flow
- repair or replacement of current control valves to meet acceptable performance
- add SCADA alarming and well shutdowns for flows that may approach permit limits
- evaluate the possibility to amend current DEP permits to allow a higher instantaneous maximum flow rate at specific wells – DEP consolation and permitting required
- operator training on system and well operations will be conducted at a more frequent basis to ensure awareness of all permit conditions and any short or long term solutions detailed in this letter
