PART I: SCHEDULE OF RATES AND CHARGES

Section A - Rates for Metered Service

- 1. <u>Customer Charge</u>: Each customer will be assessed a quarterly customer service (I) charge of nineteen dollars (\$19.00).
- 2. <u>Consumption Charge</u>: In addition to the customer charge, the following water consumption charges will apply:
