Pittsburgh UNITED writes to advise Your Honors and parties of a slight revision to the Direct Testimony of Pittsburgh UNITED witnesses Mitchell Miller and Bruce Lanphear. These revisions are as follows:

- **Pittsburgh UNITED Statement C-1, Mitchell Miller:**
 - Strike lines 1 and 2 on page 47 and associated footnote.
- **Pittsburgh UNITED Statement C-3, Bruce Lanphear:**
 - Strike portions of lines 9 and 10 on page 39 and associated footnote.
 - Strike portions of lines 12 and 13 on page 40.
 - Strike portions of line 12 and 13 on page 46.

Pittsburgh UNITED agreed to make these modifications because PWSA addressed the identified issue.

Please note that the above revisions were able to be contained within the noted pages, and that the remaining pagination and line numbering from the original versions otherwise remain unchanged.

Electronic copies (clean and redlined versions) of the revised Statements are being circulated to Your Honors and all parties. A hard copy of the revised pages (clean and redlined versions) will also be circulated to Your Honors and all parties. Given the volume of the original documents, which remain largely unchanged, we do not intend to circulate hard copies of the full revised statements. That said, we are happy to provide a hard copy of the full revised statements to Your Honors or any party upon request, and note that we intend to present the revised statements to the record at hearings, and will provide the court reporter with copies of the full revised statements at that time.

Finally, please be advised that Pittsburgh UNITED will not be filing Rebuttal Testimony in this proceeding.
