Dear Parties and Mr. Beall:

I am in receipt of correspondence from Mr. Beall dated July 12, 2019. For the convenience of the parties, a copy of the letter is included with this correspondence.

Mr. Beall reports that he is the attorney for Beatrice Sullivan, the last surviving child of George N. Schaefer. He also states that Mr. Michael Symes is a courtesy contact for Mr. Beall in the context of his representation of Mrs. Sullivan, suggesting that Mr. Symes does not represent Mr. Schaefer. Mr. Symes has been listed on the service list of the eminent domain application related to property which Duquesne Light represents that Mr. Schaefer is the owner.

At prehearing conferences held in this matter, counsel for Duquesne Light appeared to be under the impression that Mr. Symes represented the estate of Mr. Schaefer. A closer reading of the application for eminent domain reveals that Mr. Schaefer died intestate in 1946 and Mrs. Sullivan, his child, is one of several potential heirs to the property at issue. Indeed, Gary Smith appeared at the initial prehearing conference, representing that he was an heir to George Schaefer. This scenario raises an issue as to whether proper notice of the application was made to all of the owners or potential owners of the property.

Accordingly, if Mrs. Sullivan would like to be informed of the proceedings and continue to receive service of my orders and decisions in this matter, she may file an appropriate petition in accordance with Commission regulations. Should Mr. Beall choose to represent her, he should file a request for admission pro hac vice if he is not licensed to practice in Pennsylvania. Alternatively, orders and decisions related to this case can be accessed from the Commission's website at <a href="www.puc.pa.gov">www.puc.pa.gov</a> by using the docket numbers for either application.

Mr. Symes will be removed from the official service list for the case.

Counsel for Duquesne Light should be prepared to address the issue of whether notice of the eminent domain application was complete and proper prior to final disposition of these applications.
