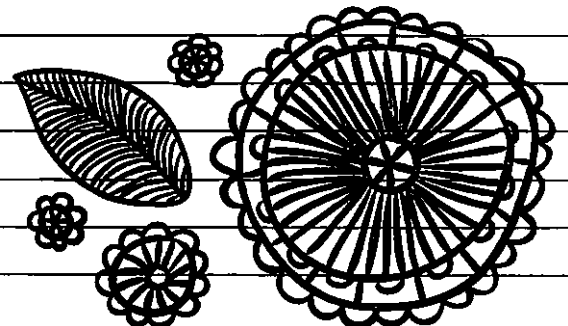
TO WHOM IT MAY CONCERN:

PS: THE PROJECT SHOULD HAVE HAD MOON TOWNSHIP IN NAME, VERY MISLEADING

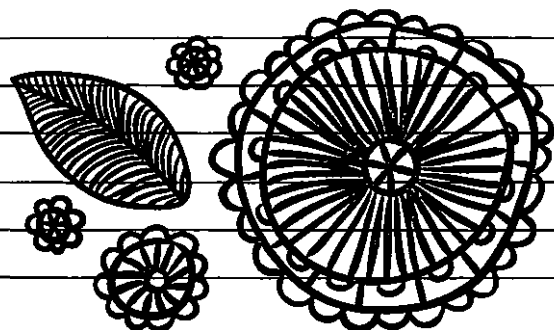

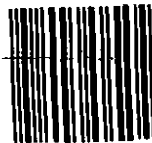
