PUBLIC STATEMENT OF THE OFFICE OF SMALL BUSINESS ADVOCATE

The Small Business Advocate is authorized and directed to represent the interest of small business consumers of utility services in Pennsylvania under the provisions of the Small Business Advocate Act, Act 181 of 1988, 73 P.S. §§ 399.41 - 399.50 ("Act"). Section 399.45(f) of the Act requires the Small Business Advocate to issue publicly a written statement stating concisely the specific interest of small business consumers to be protected by his initiation of, or intervention in, any proceeding involving those interests before the Public Utility Commission ("Commission") or any other agency or court. This public statement relates to the filing today by the Small Business Advocate of a Notice of Intervention in the Petition of UGI Utilities, Inc. – Electric Division ("UGI" or the "Company") for Approval of a Distribution System Improvement Charge ("DSIC").

The Small Business Advocate files this Notice of Intervention to protect the interests of UGI's small business customers. A thorough inquiry by the Commission into the Company's DSIC Petition is necessary to ensure that a DSIC would lawful, just, and reasonable.

In view of the foregoing, the Small Business Advocate will participate in proceedings before the Public Utility Commission to investigate the reasonableness of the proposed DSIC. The Small Business Advocate will ask the Commission to deny UGI's proposed DSIC unless the record evidence proves that a DSIC would be lawful, just, reasonable, and not unduly discriminatory to the Company's small business customers.
