Dear Secretary Chiavetta,

Pursuant to the Commission approved settlement of the above-captioned rate case proceeding ("Rate Case Settlement"), Pittsburgh Water and Sewer Authority ("PWSA") provided to the Parties on April 30, 2019 and July 31, 2019 the various agreed-to information. Currently pending before the Commission is a Joint Petition for Partial Settlement related to PWSA's Compliance Plan ("Compliance Plan Settlement").<sup>1</sup> As part of the Compliance Plan Settlement, PWSA agreed to file comprehensive quarterly Compliance Plan Progress Reports to report on all the commitments made in the Compliance Plan Settlement in addition to those made in the Rate Case Settlement.<sup>2</sup> Even though the Compliance Plan Settlement is still pending before the Commission, PWSA agreed to begin filing the comprehensive Compliance Plan Progress Reports on or before October 31, 2019.<sup>3</sup>

Therefore, please accept this letter as notice that the information PWSA agreed to provide pursuant to the above-captioned Rate Case Settlement is included in the Compliance Plan Progress Report being filed at consolidated docket numbers: M-2018-2640802 (water), M-2018-2640803 (wastewater), P-2018-3005037 (water) and P-2018-3005039 (wastewater). This agreed-to Rate Case Settlement information includes: 1) the data specified in Paragraph III.A.2; 2) the Highland Membrane Filtration Plant report identified in Paragraph III.H.4.i; and 3) an update on the status of negotiations with the City of Pittsburgh related to the Cooperation Agreement as required by Paragraph III.G.1.a. Going forward, PWSA will continue to include this Rate Case Settlement information in the Compliance Plan Progress Reports that will be filed at consolidated docket numbers: M-2018-2640802 (water), M-2018-2640803 (wastewater), P-2018-3005037 (water) and P-2018-3005039 (wastewater).


