
ORDER

THEREFORE,

IT IS ORDERED:

1. Main briefs must be filed and received in hand by the other parties either electronically or in-hand via hard copy by 4:00 p.m. on January 6, 2020. If initially filed and submitted to the other parties electronically, hard copies of the briefs must be placed in the mail on January 6, 2020.
2. Reply briefs must be filed and received in hand by the other parties either electronically or in-hand via hard copy by 4:00 p.m. on January 16, 2020. If initially filed and submitted to the other parties electronically, hard copies of the briefs must be placed in the mail on January 16, 2020.
3. Word versions of the main and reply briefs must be provided to the Administrative Law Judges at the time they are filed with the Commission.
4. In addition to the brief requirements set forth in 52 Pa. Code §5.501(a), main briefs must also include the items set forth in 52 Pa. Code §5.501(b).
5. As discussed following the evidentiary hearings, the parties are directed to confer and utilize a common brief format for organizing main and reply briefs.
