Enclosed for filing on behalf of UGI Utilities, Inc. – Gas Division (“UGI Gas” or the “Company”) are originals of Supplement No. 6 to UGI Gas Tariff – PA P.U.C. Nos. 7 and 7S, seeking a general rate increase pursuant to 66 Pa.C.S. § 1308 of the Public Utility Code. Also enclosed is an original Statement of Reasons along with the supporting data and testimony, including data required by 52 Pa. Code §§ 53.52 and 53.53. Electronic copies of all the documents submitted in support of this filing are provided on the enclosed USB flash drive.

In this filing, UGI Gas is proposing to increase its annual jurisdictional revenues by approximately \$74.6 million, or by 8.5% on a total revenue basis. Average customer bill impacts are detailed in the enclosed Statement of Reasons. UGI Gas is proposing that the new distribution rates become effective for service rendered on or after March 28, 2020.
