

In addition to the corrections listed above, the OCA notes the following corrections that should be made to the transcript:

- Administrative Law Judge Angela T. Jones is referred to throughout the transcript as “The Chair.”<sup>2</sup>
- The term “Commission” has been transcribed as “Comission” throughout the transcript.
- The location of the January 24, 2020 Evidentiary Hearing is identified on the cover page as “Hearing Room 4, Commonwealth Keystone Building, Harrisburg, Pennsylvania.” The

<sup>2</sup> Previous transcripts transcribed for the Pennsylvania Public Utility Commission, however, typically refer to the Presiding Officer by her complete title (e.g., “Administrative Law Judge Angela T. Jones”) when first referencing the Presiding Officer, followed by references to the Presiding Officer by the title “Judge” and the Presiding Officer’s last name (e.g. “Judge Jones”).

Evidentiary Hearing was actually held in a hearing room on the 4<sup>th</sup> floor of the Commission's Philadelphia location at 801 Market Street. The parties participated telephonically.

- The page number references in the Exhibit Index on pages 51 through 53 of the transcript, under the column headings "FOR IDENTIFICATION" and "IN EVIDENCE," are incorrect.


The OCA respectfully requests that these revisions to the transcript also be approved, in addition to the transcript corrections noted in the table above.
