Petition for Extension of Time to File Exceptions and Reply Exceptions

#### Dear Secretary Chiavetta:

By Secretarial Letter dated February 28, 2020, you set a due date of March 11, 2020 for Exceptions, and a due date of March 18, 2020 for Replies to Exceptions regarding the Recommended Decision in this matter.

I&E respectfully requests that the due date for Exceptions be extended to March 13, 2020, and the due date for Replies to Exceptions be extended to March 23, 2020. This extension will provide two additional business days between issuance of the Recommended Decision and the Exceptions due date, and one additional business day between the Exceptions and Replies to Exceptions due dates. This additional time is requested because of the need to coordinate three separate Exceptions and Replies to Exceptions to three separate Recommended Decisions in this consolidated proceeding during an already shortened exceptions period. The OCA and OSBA support, and Valley does not oppose, this request. I&E notes Valley's non-opposition is limited to this specific request only. Therefore, I&E respectfully requests the Commission only consider its specific request and not grant any alternative extension of time.
