## Dear Ms. Hilton:

Pursuant to the Settlement Agreement with the Pennsylvania Public Utility Commission ("PUC" or "Commission"), <sup>1</sup> The Pittsburgh Water and Sewer Authority ("PWSA" or "Authority") agreed to formally notify the City of Pittsburgh ("City") of the Commission's Order on PWSA's Compliance Plan Filing proceeding, <sup>2</sup> and that PWSA's Long Term Infrastructure Improvement Plan ("LTIIP") Filing.<sup>3</sup>

The Settlement Agreement was reached by certain active parties (collectively, the "Joint Petitioners") in the July 2, 2018 base rate increase filing. That settlement must be reviewed and approved by the Commission.

PWSA's Compliance Plan filing is at Docket Nos. M-2018-2640802 (water) and M-2018-2640803 (wastewater). The Compliance Plan filing consists of six documents:


