Dear Secretary Chiavetta:

Enclosed for filing on behalf of UGI Utilities, Inc. – Gas Division (“UGI Gas”) is Supplement No. 11 to Tariff UGI Gas Pa. P.U.C. Nos. 7 and 7S, which voluntarily suspends the rates and regulations proposed in Supplement No. 6 to Tariff UGI Gas Pa. P.U.C. Nos. 7 and 7S (“Supplement No. 6”) so that they will become effective on November 19, 2020.

By way of background, on January 28, 2020, UGI Gas filed Supplement No. 6 with the Pennsylvania Public Utility Commission (“Commission”). As filed, the rates proposed in Supplement No. 6 were to become effective March 28, 2020. Supplement No. 6 was suspended until October 28, 2020, by the Commission’s Order entered at Docket No. R-2019-3015162 on February 27, 2020. The suspension period was reflected in Supplement No. 8 to Tariff UGI Gas Pa. P.U.C. Nos. 7 and 7S, which was filed on March 5, 2020. On March 26, 2020, UGI Gas filed Supplement No. 10 to Tariff UGI Gas Pa. P.U.C. Nos. 7 and 7S, which proposed a one-day extension of the suspension period in order to accommodate the second Commission public meeting in October 2020. In light of the ongoing challenges facing the Commonwealth of Pennsylvania associated with COVID-19, UGI Gas has agreed to a further voluntary extension of the suspension period in this proceeding to November 19, 2020.
