We are counsel to Reynolds Disposal Company ("RDC" or "Company"). Please accept this letter as the Company's petition/request for an extension of time for the filing of a general rate increase based on an operating income statement and other data for the historic twelve months ended December 31, 2019 and the future twelve months ending December 31, 2020. With an historic test year ended December 31, 2019, RDC would be required by 52 Pa. Code Section 53.52(b), the "120 Day Rule," to make its general rate filing by April 29, 2020. Through this petition/request, RDC seeks an extension of time to enable it to submit the filing on or before July 1, 2020.

RDC is presenting this petition/request as it needs additional time to accumulate the required financial and other information for its rate submission. The Company's most recent prior general rate filing was in 2010.
