Enclosed for electronic filing please find Philadelphia Gas Works' ("PGW") Tariff Supplement No. 132 to its Gas Service Tariff – Pa. P.U.C. No. 2 and Tariff Supplement No. 89 to its Gas Supplier Tariff – Pa. P.U.C. No. 1 with regard to the above-referenced matter ("Tariff Supplements"). The Tariff Supplements voluntarily suspend the rates and regulations proposed in Supplement No. 128 to Gas Service Tariff – Pa. P.U.C. No. 2 and Supplement No. 85 to Gas Supplier Tariff – Pa. P.U.C. No. 1 until December 4, 2020.

By way of background, on February 28, 2020, PGW filed Supplement No. 128 to Gas Service Tariff – Pa. P.U.C. No. 2 and Supplement No. 85 to Gas Supplier Tariff – Pa. P.U.C. No. 1. As filed, the rates and regulations proposed were to become effective April 28, 2020. Supplement Nos. 128 and 85 were suspended until November 28, 2020, by the Commission's Order entered at Docket No. R-2020-3017206 on April 16, 2020. The suspension period was reflected in Supplement No. 131 to PGW's Gas Service Tariff – Pa. P.U.C. No. 2 and Supplement No. 88 to PGW's Gas Supplier Tariff – Pa. P.U.C. No. 1, which were filed on April 27, 2020. Due to challenges created by the COVID-19 pandemic, PGW agreed to a voluntary extension of the suspension period to December 4, 2020. The extension of the suspension period to December 4, 2020, is reflected in the enclosed Tariff Supplements.
