Dear Secretary Chiavetta:

Pennsylvania-American Water Company (“PAWC” or the “Company”) has been served with a number of formal complaints in the above-captioned matter and anticipates that additional formal complaints will be filed. On May 21, 2020, the Commission entered an Order initiating an investigation of the Company’s rate increase request at the above-referenced docket numbers. The Company anticipates that all complaints filed with respect to its proposed rate increase will be consolidated in that proceeding. Accordingly, with respect to the complaints that have been filed for which answers are not yet due, and any complaints hereafter filed, the Company, in lieu of filing answers, will rely upon 52 Pa. code § 5.61(d), which provides:

For complaints which are docketed with Commission-instituted rate proceedings, an answer may be filed within the time specified. However, no answer is required, except as may be directed by the Commission or the presiding officer.
