Dear Secretary Chiavetta:

We are counsel to Aqua Pennsylvania Wastewater, Inc. ("Aqua" or "Company") in connection with its above referenced Application, filed with the Public Utility Commission ("Commission") on March 3, 2020, pursuant to Sections 1102, 1329 and 507 of the Public Utility Code, for approval of the acquisition of the wastewater system assets of the Delaware County Regional Water Quality Control Authority. By letters dated May 6, 7, 8 and 13, 2020, we provided responses to Information Requests of the Bureau of Technical Utility Services, including a Supplemental Response to Information Request 8 and responses to Information Requests 14, 16, 32 and 33. This letter supplements those responses as follows:

INFORMATION REQUEST 8:

Checklist Item Nos. 12 and 18.a. – The Application's Exhibit A4 indicates DELCORA serves several customers in Upper Providence Township. However, the Applications' Exhibits G and H do not include rates for DELCORA's customers in Upper Providence Township. Please amend the following:

- a. The Application's Exhibit G to include the rates for Upper Providence Township customers; and
- b. The Application's Exhibit H to include a copy of the DELCORA resolution establishing rates for customers in Upper Providence Township.

RESPONSE:

In the amended Exhibit A4 (Edgmont) Service Territory Map, provided with our letter of May 8, 2020, the two parcels adjoining segment 78 to the northwest are served from the main

coming from Carnoustie Way. The two parcels adjoining segment 73 located to the northwest are similarly served from the main in Carnoustie Way. DELCORA owns the sewer main in Carnoustie Way and provides service to these customers.

The amended Exhibit A4 Service Territory Map, provided with our letter of May 8, 2020, removed parcels in Upper Providence Township and parcels bordering Edgmont Township and Upper Providence Township. All parcels that have been excluded are served by a main not shown on the amended Exhibit A4 Service Territory Map that is owned and operated by Upper Providence Township, and, therefore, are not customers of DELCORA.

The main shown in Kingston Road is a capped sewer installed by the developer at the time of development and no customers are anticipated to be connected to that main.

INFORMATION REQUEST 14:

Checklist Item No. 18.c. – The Application's Exhibit G does not include APW's proposed rates, rules and conditions of service regarding eligibility requirements to be considered a member of the following customer classes indicated in the Application's Exhibit H, Resolutions Nos. 21-25 and 30: Western Wholesale, EDU Wholesale, Retail Industrial, Wholesale Industrial, Eastern Wholesale and Chester Ridley Creek. Please amend the Application's Exhibit G to include APW's proposed rates, rules and conditions of service regarding eligibility requirements to be considered a member of each of these customer classes.

RESPONSE:

An amended Application Exhibit G – Schedule of Rates Tariff Pages, including APW's proposed rates, rules and conditions of service regarding eligibility requirements to be considered a member of each of the referenced customer classes, is included with this letter.

INFORMATION REQUEST 16:

Checklist Item No. 18.d. - The Application's Exhibit H indicates that the DELCORA Western Wholesale customer class is billed \$2.87 per thousand gallons and the DELCORA EDU Wholesale customer class is billed \$2.89 per thousand gallons. The Application's Exhibit U2, Appendix A, Page 2 appears to indicate APW is proposing a new APW Western Wholesale customer class to include both the DELCORA Western Wholesale and DELCORA EDU Wholesale customer classes. Please provide an amended version of the Application's Exhibit I11 to include a copy of the notification sent, or which will be sent, to the APW Western Wholesale customer class to describe the filing and the anticipated effect on rates for both the DEL CORA EDU Wholesale and DELCORA Western Wholesale subclasses.

RESPONSE:

An amended version of Application Exhibit I11, the notice to be sent to Western Wholesale customers, and a new Application Exhibit I13, notice to EDU Wholesale Customers, is

included with this letter. Also attached is an updated Appendix A to Application Exhibit U2. The CONFIDENTIAL excel file version of Appendix A to Application Exhibit U2 is being provided to the Secretary of the Commission by email correspondence.

INFORMATION REQUEST 32:

Checklist Item No. 25 – The Application's Exhibit F101 is missing Exhibits A, B and C. Please provide copies of these exhibits.

RESPONSE:

The Company is working with DELCORA and Nether Providence to obtain a copy of the missing exhibits, and the Company will provide that information when it is received.

INFORMATION REQUEST 33:

Checklist Item No. 25 – The Application's Exhibit F103 is missing its copy of its Exhibit A map area and boundary description. Please provide a copy of this exhibit.

RESPONSE:

DELCORA owns both the City of Chester sewer system and the Rose Valley sewer system. Therefore, this contract will be removed from the assigned contracts list.

The Verification of William C. Packer verifying the foregoing is attached hereto.

Aqua believes that, with this letter and accompanying information, it has complied with the Bureau of Technical Utility Services requests for supplemental information and asks that the Public Utility Commission acknowledge that the Application has been perfected.

HAULED WASTE DISPOSAL CHARGE

The following rates shall be charged to private contractors that haul and deliver waste at the Company's Western Regional Wastewater Treatment Plant in Chester, Pennsylvania.

<u>Class I - Domestic Waste</u>: Liquid waste collected from domestic residences and businesses. This includes liquid waste generated from onsite septic/drain field systems, portable toilets, dishwasher, toilet, shower and other liquid wastes typically generated by a domestic residence. This does not include commercial food processing, car wash, grease interceptors and industrial wastewaters. The combined Total Suspended Solids (TSS) and Chemical Oxygen Demand (COD) of this material is required to remain under 10,000 mg/l.

Class I Rate: \$0.02 per gallon

<u>Class II - Package Plant</u>: Sludge generated from domestic wastewater treatment plants serving residential communities. For a facility to be classified as a package plant it must have a design capacity less than or equal to 1.0 Million Gallons per Day.

<u>Class III - Industrial Wastewater</u>: Liquid waste generated from non-domestic and non-food processing operations. This includes production wastewater, groundwater, stormwater and wash waters.

For each additional 10,000 mg/I COD Surcharge of \$0.005 per gallon

Class IV Discount: A discount of 10.00% shall apply for over 300,000 gallons per month.

<u>Class V - Form Waste</u>: Sludge generated from Municipal Wastewater Treatment Plants with design flows greater than 1 Million Gallons per Day and Sludge generated from industrial facilities greater than 2.0% total solids

Class V Rate: Waste stream with TSS <= 4.0% \$0.045 per gallon
