Dear Secretary Chiavetta:

On April 29, 2020, Pennsylvania-American Water Company (the “Company”) filed Supplement No. 19 to Tariff Water-PA P.U.C. No. 5 and Supplement No. 19 to Tariff Wastewater-PA P.U.C. No. 16 for a rate increase to become effective June 28, 2020.

On May 21, 2020, the Pennsylvania Public Utility Commission (the “Commission”) entered an Order suspending, by operation of law, Supplement No. 19 to Tariff Water-PA P.U.C. No. 5 and Supplement No. 19 to Tariff Wastewater-PA P.U.C. No. 16, until January 28, 2021. On May 27, 2020, in response to Ordering Paragraph 3, the Company filed Supplement No. 20 to Tariff Water-PA P.U.C. No. 5 and Supplement No. 20 to Tariff Wastewater-PA P.U.C. No. 16.

On June 4, 2020, Chief Administrative Law Judge Charles E. Rainey, Jr. entered an Order granting the Office of Consumer Advocate’s Expedited Motion for an Extension of the Statutory Suspension Period. In response to the Prehearing Order dated June 15, 2020, the Company was directed to file with the Commission tariff supplements suspending for investigation the Company’s tariff supplements for an additional 45 days or until March 15, 2021.

Enclosed are Supplement No. 21 to Tariff Water-PA P.U.C. No. 5 and Supplement No. 21 to Tariff Wastewater-PA P.U.C. No. 16 further suspending the investigation until March 15, 2021. These tariff supplements have been posted at the Company’s office.
