In accordance with the November 14, 2019 Order entered by Administrative Law Judge Steven K. Haas in the above-referenced matter ("Order"), this status report is being filed, on behalf of all the parties, to provide an update on settlement discussions since the last letter status report filed on June 17, 2020.

Since the last update, the Bureau of Investigation and Enforcement, the Office of Consumer Advocate, Indian Springs Water Company, Glen Summit Company and Pennsylvania-American Water Company have been actively working on the terms of a settlement, including calls on June 19, 2020, July 7, 2020 and July 9, 2020 as well as the exchange of emails. The parties feel that they are close to an agreement-in-principle that would resolve all of the issues in this proceeding and therefore see no need to establish a procedural schedule at this time. The parties will continue their efforts to negotiate a settlement and will file another status report in 30 days, as required by the Order.
