PREHEARING MEMORANDUM OF
EDGMONT TOWNSHIP

In accordance with the Administrative Law Judge's Further Corrected Prehearing Conference Order dated August 17, 2020, and 52 Pa. Code § 5.222(d)(1), Edgmont Township ("Edgmont") hereby files this Prehearing Memorandum and provides the following information to the Administrative Law Judge and the active parties to this proceeding.

Procedural History: On June 15, 2020, Edgmont filed a Petition to Intervene. Subsequently, on August 17, 2020, Edgmont filed a Petition for Leave to Withdraw its Petition to Intervene and replace it with a simultaneously filed Protest against the proposed acquisition of the wastewater assets of Delaware County Regional Water Quality Control Authority ("DELCORA") by Aqua Pennsylvania Wastewater, Inc. ("Aqua").

Issues: Edgmont has reviewed Aqua's Application and exhibits, the direct testimony of witnesses from Aqua and DELCORA, and numerous responses to interrogatories provided by Aqua and DELCORA (including responses to discovery

propounded by Edgmont). Based on that information, Edgmont intends to address the following issues:

- Whether DELCORA has the right to transfer to Aqua the property used to serve Edgmont;
- Whether an agreement exists between Aqua and Edgmont that Aqua is permitted to file with the Commission under 66 Pa. C.S. § 507;
- Whether it is consistent with the public convenience and necessity for Aqua to acquire the assets and contract rights of DELCORA;
- Whether Aqua's acquisition of the assets and contract rights of DELCORA would affirmatively promote the service, accommodation, convenience, or safety of the public in some substantial way; and
- Whether it is consistent with the public interest, the law, and the Pennsylvania Constitution for Aqua to acquire the assets of DELCORA without providing appropriate credit to customers who contributed property to DELCORA.


