Dear Judges Long and Devoe:

On May 15, 2020, the Pittsburgh Water and Sewer Authority ("PWSA") served to Your Honors and the parties in this proceeding Supplemental Direct Testimony which included, among other issues, updated proposals regarding PWSA's March 6, 2020 initial rate filing following the Commission's March 26, 2020 Order. Subsequently, on July 30, 2020, Governor Wolf signed into law Act 70 which provides that the Cooperation Agreement between PWSA and the City of Pittsburgh has "the full force and effect of law." Given this change in law, PWSA has elected to withdraw the proposals set forth in its Supplemental Direct Testimony addressing issues governed by the Cooperation Agreement and revert to its initial proposals as set forth in its March 6, 2020 initial filing.

To effectuate the withdrawal of its revised positions regarding City Cooperation issues, PWSA redacted the relevant portions of its Supplemental Direct Testimony and is serving copies of the revised Supplemental Direct Testimony herein. PWSA is not withdrawing issues addressed in the Supplemental Direct Testimony beyond those governed by the Cooperation Agreement.
