**AMENDMENT #1 TO AGREEMENT  
FOR CONTRACT OPERATION AND MAINTENANCE  
OF FACILITIES  
DATED JANUARY 27, 2009**

THIS AMENDMENT is made as of the 1st day of January, 2013 between the DELAWARE COUNTY REGIONAL WATER QUALITY CONTROL AUTHORITY (hereinafter "OPERATOR"), a Pennsylvania Municipal Authority with offices at 100 East Fifth Street, Chester, Pennsylvania, and SPRINGHILL FARM WASTEWATER TREATMENT FACILITY ASSOCIATION (hereinafter "OWNER").

**RECITALS:**

WHEREAS, OPERATOR and OWNER entered into that certain Agreement for Contract Operation and Maintenance dated January 27, 2009 (the "2009 Agreement"); and

WHEREAS, OPERATOR and OWNER desire to amend certain provisions of the 2009 Agreement and agree to hereby do so; and

WHEREAS, the parties hereto desire to reaffirm all other provisions of the 2009 Agreement which are not specifically amended hereby.

NOW, THEREFORE, with the foregoing recitals made part hereof and incorporated herein, the parties hereto, intending to be legally bound, hereby agree as follows:

1. Section 1.2 of Exhibit A – Scope of Services of the 2009 Agreement shall be amended by deletion of the existing Subsection 1.2.r in its entirety and replacement thereof with the following new Subsection 1.2.r., which hereafter shall be part of the 2009 Agreement and shall read as follows:

“r. [Intentionally Omitted]”

2. Paragraph 1. of Exhibit C – Compensation of the 2009 Agreement shall be amended by deletion of the existing Subparagraph 1.a) in its entirety and replacement thereof with the following new Subparagraph 1.a) which hereafter shall be part of the 2009 Agreement and shall read as follows:

“a) The OWNER shall pay OPERATOR a Monthly Operating Fee of \$3,257.65 for the operation and maintenance of the Facilities as defined in this Agreement, with adjustments and additions as contained herein, based on a starting date of January 1, 2013.”

3. All other provisions, terms and conditions of the 2009 Agreement which are not specifically amended hereby shall remain in full force and effect. OPERATOR and OWNER hereby reaffirm the aforesaid 2009 Agreement as amended hereby.

IN WITNESS WHEREOF, the parties hereto have caused this Amendment to be executed as of the date and year first written above by their respective duly authorized officers and their respective seals to be hereunto fixed.
