AGREEMENT CONTAINING AN EASEMENT TO PERMIT DELCORA TO OPERATE AND MAINTAIN SEWAGE FACILITIES UPON THE LANDS OF SOUTHWEST, DATED OCTOBER 15, 2012, BY AND AMONG SOUTHWEST DELAWARE COUNTY MUNICIPAL AUTHORITY AND DELCORA

AGREEMENT BETWEEN THE DELAWARE COUNTY REGIONAL WATER QUALITY CONTROL AUTHORITY ("DELCORA") AND SOUTHWEST DELAWARE COUNTY MUNICIPAL AUTHORITY ("SWDCMA"). CONTAINING AN EASEMENT TO PERMIT DELCORA TO OPERATE AND MAINTAIN SEWAGE FACILITIES UPON THE LANDS OF SOUTHWEST.

THIS AGREEMENT ("Agreement") made this 15th day of October, 2012, between the **DELAWARE COUNTY REGIONAL WATER QUALITY CONTROL AUTHORITY**, (hereinafter referred to as "DELCORA"), a Pennsylvania municipal authority with an address at 100 East Fifth Street, Chester, Pennsylvania, and **SOUTHWEST DELAWARE COUNTY MUNICIPAL AUTHORITY** (hereinafter referred to as "SWDCMA"), a Pennsylvania Municipal Authority with an address at 1 Gamble Lane, Aston, Pennsylvania, provides as follows:

BACKGROUND

DELCORA is a municipal sewer authority that operates, among other things, a sewage treatment plant known as the DELCORA Western Regional Treatment Plant (hereinafter referred to as the "WRTP"). SWDCMA is the owner of a parcel of land located along Gamble Road in the Township of Aston, Pennsylvania and being folio no. 02-00-02914-01 (the "Aston Property") upon which DELCORA intends to construct and maintain a sewage pump station and force main facility to convey sewage to the WRTP consisting of a pump station , force main, sewer lines, utilities and other incidental improvements (collectively, the "Sewage Facilities") in the area of the Property as shown on the Easement Plan prepared by Catania Engineering Associates, Inc. which is identified as Exhibit "A" attached hereto, incorporated herein and made a part hereof (the "Plan").

The parties desire that DELCORA operate and maintain the Sewage Facilities.

NOW, THEREFORE, in consideration of the foregoing BACKGROUND, which is incorporated herein and made a part hereof, and of the mutual agreements herein contained, and intending to be legally bound hereby, DELCORA and SWDCMA hereby agree as follows:

AGREEMENT

1. SWDCMA hereby grants and conveys to DELCORA an exclusive easement upon, across and under the area shown on the Plan as "PROPOSED SANITARY SEWER EASEMENT AREA" having an area of approximately 0.81 ac. and as more particularly described in the legal description attached hereto as Exhibit "B" which is incorporated herein and made a part hereof (the "Easement Area") for sole purpose of operating, maintaining, repairing, upgrading and replacing the Sewage Facilities, including sewer lines and piping of DELCORA and others running within, into and out of the Easement Area, together with the right of access, ingress and egress on, upon and across the lands of SWDCMA adjacent to or near the Easement Area to the extent reasonably necessary to provide DELCORA with access to the Easement Area, including but not limited to the right to use and traverse such driveways (if any) as may exist from time to time on the lands of SWDCMA adjacent to or near the Easement.

- 2. DELCORA shall compensate SWDCMA for the easement upon signing of this agreement an amount equal to present market value as agreed upon by both parties. The easement granted above is subject to all matters of record as of the date of this Agreement.
- 3. DELCORA shall be solely responsible for the operation, maintenance, repair, upgrade and replacement of the Sewage Facilities and SWDCMA shall not be required to furnish any service in connection therewith. In the exercise of its rights and obligations hereunder, (i) DELCORA shall comply in all material respects with all applicable laws, regulations, ordinances and codes, (ii) DELCORA shall undertake all work diligently and in a good and workmanlike manner and (iii) DELCORA shall at all times maintain fencing and screening around the Sewage Facilities in good and proper condition.
- 4. This Agreement shall run with the land and shall burden SWDCMA's property. This Agreement shall inure to the benefit of, and be binding upon DELCORA, SWDCMA, and their respective successors and assigns. This Agreement, once executed and delivered, shall not be modified, supplemented, amended or altered in any respect except by a writing signed by both DELCORA and SWDCMA or their respective successors or assigns.
- 5. This Agreement shall be executed in any number of counterparts, each of which shall constitute an original, but all of which together shall constitute the same instrument.

IN WITNESS WHEREOF, DELCORA and SWDCMA have caused this Agreement to be executed as of the date first above written.


