

NOTICE OF WITHDRAWAL OF PROTEST OF

Pursuant to 52 Pa. Code § 5.94(b), Edgmont Township (“Edgmont”) hereby withdraws its Protest in this proceeding. Edgmont is withdrawing its Protest because it has entered into a Joint Stipulation with Aqua Pennsylvania Wastewater, Inc. (“Aqua”) and Delaware County Regional Water Quality Control Authority (“DELCORA”) (“Joint Stipulation”), a copy of which is attached hereto as Appendix A. #### JOINT STIPULATION OF AQUA PENNSYLVANIA WASTEWATER, INC., EDGMONT TOWNSHIP, AND DELAWARE COUNTY REGIONAL WATER QUALITY CONTROL AUTHORITY

---

Aqua Pennsylvania Wastewater, Inc. (“Aqua”), Edgmont Township (“Edgmont”), and Delaware County Regional Water Quality Control Authority (“DELCORA”), (collectively “the Stipulating Parties”), pursuant to 52 Pa. Code § 5.234, enter into a Joint Stipulation to resolve their differences with regard to the above-captioned Pennsylvania Public Utility Commission (“Commission”) proceeding (“Application Proceeding”). The Parties Stipulate and Agree as follows.

#### STIPULATION TERMS

1. Edgmont has protested the above-captioned Application Proceeding, presented testimony, and litigated certain contractual issues relating to the proposed acquisition of DELCORA’s system assets by Aqua (“Proposed Transaction”). This Joint Stipulation between and among the Stipulating Parties resolves all issues associated with Edgmont’s Protest of the Application Proceeding.

2. Pursuant to an existing agreement, Application Exhibit F81, DELCORA provides retail wastewater service to customers in the Crum Creek Sewer District of Edgmont (“Service Agreement”). The Service Agreement provides that DELCORA cannot assign the Service

Agreement without Edgmont's consent, and it also provides Edgmont with a right of first refusal to acquire DELCORA's collection system in the Crum Creek Sewer District of Edgmont.

3. The Stipulating Parties agree as follows:

A. Edgmont and DELCORA have amended the Service Agreement and, as part of that amendment, Edgmont has consented to the assignment of the amended Service Agreement by DELCORA to Aqua at the time of closing the Proposed Transaction; and Edgmont has agreed not to exercise its right to acquire DELCORA's collection system in Edgmont.

B. Edgmont will withdraw its Protest to the Application.

C. No later than 30 days prior to closing of the Proposed Transaction, Aqua will file the Service Agreement as amended with the Commission pursuant to 66 Pa. C.S. § 507.


